## Annual Family Stewardship Campaign

### WHAT IS THE ANNUAL FAMILY STEWARDSHIP CAMPAIGN (AFSC)?

Each year, from November through March, families like yours prayerfully consider a tax-deductible donation to the organization. AHG, Inc. depends on this campaign to assist in keeping membership fees reasonable for your family and your Troop's charter partner.

### WHAT SPECIFICALLY DOES THE AFSC PAY FOR?

The campaign monies are not designated to any particular expense category. AFSC helps pay for a portion of budgeted expenses related to the ministry. The AHG, Inc. management staff determines the annual operating budget and the National Board of Trustees approves the budget. Each year a projection of donations is made trusting that the Lord will provide through the stewardship of AHG's members investing in the future ministry of AHG, Inc.



### WHY DO YOU NEED MY STEWARDSHIP?

AHG stands for the ideals that made our country great. Those ideals, founded on Biblical principles, are challenged daily in our Nation's courts of law.

For this reason AHG does not accept government or United Way funding. AHG's members, alumna, and faith-filled friends have demonstrated in the past their



commitment to AHG being a financially independent and viable ministry. Individual membership and Troop charter fees do not cover the total cost of the AHG ministry. Financial support from donors like you comprises 1/3 of AHG's budget and is essential to the health and longevity of this ministry.
